**Camping & yards available \$10 per night per family camping and \$10 yard**

**Entries close on or before if filled by 8<sup>th</sup> April**

Conditions of Entry: Entry is conditional upon acceptance of these conditions.

1. Entering this clinic constitutes acknowledgement that PCV rules apply and acceptance of these rules.
2. Refunds after the closing date will only be provided if the spot can be filled by another rider. An admin fee of \$20 will be deducted for all refunds.
3. Before riding - all Open Riders must complete and submit a "Liability Declaration" form available on the day. A \$10 per day "Day Participation Fee" is also payable in addition to the entry fee UNLESS proof of current financial membership of PCAV, EV/EA, AHS, SHCA, AERA, HRCV, an interstate Pony Club or can provide proof of Personal Liability Cover of at least \$10,000,000. If you are required to pay the \$10.00 Day Participation Fee, you must also complete and submit a "Day Participation Waiver" form.
4. All riders must wear "Standards Approved" complying Helmets as specified in the current PCV Gear Rules.
5. All riders under 18 must be accompanied by a parent or guardian for the duration of the clinic
6. The organising committee reserves the right to refuse any entry with or without stating the reason.
7. Groups may be mixed grades
8. Horses must be at least four years old
9. No stallions, colts or rigs
10. PCV Alcohol policy applies
11. Lunging is permitted in the lunging area only
12. Dogs must be kept on leash at all times and away from warm-up and riding areas
13. Neither the organising committee of this clinic nor the PCV accepts any responsibility whatsoever for any accident, damage, illness to horses, riders, ground spectators or any other person or property
